6. Economic Development Update – Justin McFadden, Tim Anderson, Mayor McCabe (Handout)

- Justin McFadden
 - o City bought St. Columba Church
 - Short term Arts & culture space (3 years) then transform into affordable housing



- o Community Improvement Plan will be opening soon
- Attended local & regional meetings on tariffs, some interesting info (e.g.: approx.
 \$2000 increase per car)
- Government collects tariff and hand back to sector information on our city website
- Area to lock into is via lobby provincial & federal governments re money coming in and helping local businesses diversify supply chains
- ACI successful intake for arts grant program \$550 worth of applications with _____
 to allocate
- Wing 404 working with Arts Build Meanwhile Spaces to create space for artists here
- Parking pilot project to digital platform approved
- Tim Anderson:
 - Hospital project is moving ahead quickly into design mode (engineering & planning) and marching forward as if funding were fully in progress, so they can advocate better with design
 - The city holds several properties which we are working to leverage
- Mayor McCabe:
 - No update today speak on tariffs

7. Presentation:

- a) Joel Cotter (Director of Planning) Planning Changes for City Staff
 - Changes include Bill 23 anchor legislation (Ontario introduced Oct 2022), Bill 109 (tighter timelines), changes to heritage, governance
 - Some of these are in respond to the housing crisis 1.5 million homes by 2031
 - Streamlining processes around approvals for development include increasing staff, using simple applications handled in office, consultation times have been adjusted / eliminated, appeals have been limited
 - 16000 homes in City of Waterloo committed and support this, but needs to meet good land use planning and cost effective to community & our challenge will be around land growth
 - Parkland municipalities must have parkland plan in place & ON capped the amount of parkland charged for and exemptions for non-profit and other reasons
 - Requirement to remove Heritage properties (150 on our registry) and now must complete a full eval of all these properties & engaged consultants to help
 - Region deemed to be upper tier municipalities and took effect Jan 1 which means all items
 that were downloaded to the City no supports/ no documents / provided to help with this
 transition but staff are working collaboratively with others in municipality
 - GRCA authority was modified, has 1 regulation for all conservation authorities; now weakened around development and now responsibility of City of Waterloo. GRCA is focused on flooding /erosion
 - Ministry of Municipal Affairs authority for some official plan reports approval / amendment (massive jurisdiction and small staff team of 8). Protracted approvals & less flexibility; min turnaround is 4 months (realistically 6-8 months)
- b) Kristin Sainsbury Waterloo Region EcDev Strategy overview
 - Preview on this report will be going to council on March 24



- Collaborative project to look at updating the regional ECDEV strategy
- Partnership agreement entered between the community, City of Waterloo & Region
- Looked at who is responsible for what priorities (area municipalities vs region)
- Over 1800 Community members engaged (2022-2024) by various consultants (surveys, in person focus groups)
- Summary: wrap around services for workforce important: affordable housing, childcare, activities required, challenges for diverse ethnocultural & misalignment between job seekers & employers
- Huge need for housing (attainable), growing local supply chains, shortage of serviced employment lands, climate change & need for improved access to transit
- Top innovation hub (keep working to build) access to capital, mentorship, support & growth is limited
- Next steps work on our City of Waterloo EcDev strat plan
- Team has been going through existing strat plan to see what falls within the pillars and what needs to be prioritized, pulled forward

Motion: That WEDAC receives the 2025 Region of Waterloo Economic Development Strategy for Information and recommends Waterloo City Council endorse the strategy.

- c) Ruth Casselman Accelerator Centre
 - Bring together resources that founders need to build next generation of Can tech companies
 - In Waterloo 20 years as of 2026
 - AC starts ups (5 yr) 85% (average is 48%)
 - Over 1000 startups & \$1.8 B investment raised, 6000 jobs created
 - 4 phase incubator streams
 - Incubate plus just launched for women founders in stem
 - Accelerator stream (start & end date w specific goal in mind)
 - Just completed aerospace tech program access to bigger companies
 - Studio program 3 yr, 100k funding for startup, started w 100 companies then down to 25. Showcase next week for the 25 companies (approx. 700 jobs created via this program)
 - Launching 2nd cohort funding approved (from FedDev) Focused on diverse representation within our startups (women indigenous, newcomers, youth)
 - Refocusing on local folks for phase 2
 - BASIC lots of start of up tech co.'s need investment money & hands on support, industry connections that open doors
 - optimized operations internally using AI a lot to increase/improve productivity

a) Tariffs



- City is working on outlining key companies that have US linkages & going through process to meet with them to better understand what impacts are / could be
- Mayor to Mayor contact (Waterloo to US community) and have the discussion about we are linked and this will impact both our communities in these ways – can you reach out to your senator, congresspeople etc.
- Support provincial / federal initiatives
- b) Motion passed in February about supporting team ON & CAN and Staff looking at the Cities procurement processes
- c) Talks about interprovincial barriers are occurring at accelerated pace. Some professional associations need to also look at their barriers and prov barriers to some things like trade
- d) We have trade agreements with 50 other countries... what is possible
- e) Some pricing has increased by 450% but also swamped with orders (1 manufacturing business) Main components from US which as subject to tariffs
